<b>Location</b>	Takoma Aquatic and Community Center 300 Van Buren Street St, NW (at 3rd and Van Buren Sts)., NW Washington, DC 20011 202-576-9284, 202-576-9285  <b>FACILITY:</b> Two 8 lane 25 yard courses with Kiefer lane lines will be utilized. Colorado timing systems with scoreboard display will be used. The shallow end will be available for supervised warm-up and cool-down throughout the meet.
<b>Rules</b>	Current USA Swimming and PVS Swimming rules will govern this meet. Please pay special attention to USA Swimming Rules; 202.3.2: <i>At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.</i>
<b>Eligibility</b>	Swimmer(s) must be registered with USA Swimming and be between the ages of 11 and 14 to be accepted in this meet. Age as of February 26, 2010, shall determine swimmer's age for the entire meet. Coaches <b>MUST</b> constantly display their current USA Swimming coach credentials to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply or card is no longer valid/current. Swimmers <b>MUST</b> have a minimum IMX score of 1,800 points to enter this meet.  <b>In order to get an IMX qualifying score, a swimmer MUST compete in all 5 or 6 events.</b>  Do not run your IMX scores from Team Manager. TM will give you a score even if you do not swim all IMX events.

<p><b>Format</b></p>	<p>This will be an IMX meet. All athletes must participate in all events. Entries not submitted by email will be subject to a \$25 processing fee for teams with more than 3 swimmers. <b>Telephone entries or FAX entries will not be accepted.</b></p> <p>For entries received by e-mail, an acknowledgement that your entry file has been received within 24 hours of submission. <p><b>Awards</b></p>	<p>USA Swimming IMX plaques will be awarded for the top sixteen swimmers in each single-year age bracket and gender. Plaques will be awarded for the top three teams.</p>																
<p><b>Scoring</b></p>	<p>Hy-Tek IMX Scoring will be used exclusively. Each time will be given a point value; swimmers scores from all events will be combined for an overall IMX point total. Disqualifications and scratches will receive zero points. Scoring and awards will be determined according to single-year age groupings and the swimmers' IMX totals. <b>There will not be awards for individual events but there will be team scoring.</b></p>
